

Minutes of meeting regarding launch of AVSAR (connecting to opportunities initiative) programme in District Pulwama

A meeting of various district officers was held under the chairmanship of District Development Commissioner Pulwama on 13-12-2023, for launch of AVSAR (connecting to opportunities initiative) programme in district Pulwama.

At the outset of meeting, the chairman briefed that the AVSAR programme being an initiative program in Jammu & Kashmir that aims to connect the youth of the region with various opportunities for personal and professional development. The program focuses on providing training, mentoring, and networking opportunities to empower young individuals and equip them with the skills and knowledge necessary to succeed in today's competitive world. The program also emphasizes inclusivity and diversity by reaching out to underprivileged communities and ensuring that all youth in Jammu & Kashmir have equal access to the resources and opportunities.

Chief Planning officer Pulwama informed that a meeting in this regard has been held on 25-10-2023 wherein various decisions have taken for running the AVSAR programme. It was decided that the District Administration will initially start free super-50 NEET coaching to economically backward/under privileged students (including under privileged NEET dropouts of last year) of the district having strong academic records in medical stream in 12th class and aspire to pursue various competitive exams in medical subject especially NEET 2024 in the first phase of AVSAR programme in district Pulwama. The ideal location for running the programme has been already identified at Govt. Degree College Boys Pulwama which requires up-gradation for smooth conduct of AVSAR programme in the building. Since the identified AVSAR centre at Govt Degree College Pulwama is under the process of up-gradation and to start the super 50 NEET coaching the Principal GDC Boys Pulwama has agreed to spare two lecture halls for running the programme during winter vacation period till the AVSAR centre is made functional. 





About Field Station Bonera, Pulwama

The Field Station Bonera. Pulwama of the CSIR-IIIM Jamma is one of the largest research, development and extension stations for high value medicinal aromatic, spice and nutraceutical crops spread over an area of 60 hectares, situated at a distance of 35 kms from Srinagar in the South Kashmir area of district Pulwama at an altitude of 5400 ft above mean scalevel. The output and importance of the station is significant in terms of the development of agroetechnological protocols, post-harvest management, processing and extension of MACs under temperate agro-climatic conditions. The farm is under intensive cultivation of different medicinal and aromatic spice, and nutraceutical crops on commercial scale especially Lavender, Rose, Scented geranium, Clarysage, Artemisia, Saffron, Rosemary besides many other minor aromatic crops and culinary herbs. The farm activities consist of R&D for agro-processing, post-harvest management, production of medicinal and essential oil-bearing crops and their value-added products, generation quality planting material of high value cash crops, trainings and capacity building and involve conservation of high altitude temperate medicinal and aromatic plant species. The farm is recognized as one of the best for research, development and extension on temperate medicinal and aromatic crops, especially in lavender cultivation and extraction of lavender essential oil.

The purpose of this visit was to educate the students towards various research activities which have been practiced in the premier research labs in government sector. Students got a chance of demonstration of cultivation practices and extraction of essential oils. Dr. Shahid Rasool, gave an elaborate lecture on cultivation and extraction of aromatic and medicinal plants in India with special reference to Jammu and Kashmir. Students visited various cultivation fields of different medicinal and aromatic plants. During the visit, students
